Approval of January 14th Minutes

<u>Proposed Demolition & Mitigation - Case Number HAZ2015-00035 @ 920 South Gale Street</u> Council District Five

Address: 920 South Gale Street. The structure to be demolished is a single-family dwelling. The owner of the property, Cory Fox is requesting demolition approval. The proposed reuse of the property is an impound lot.

Description of the property and structure: The building is in a state of disrepair. The structure is a one story frame building. The property is .021 acres in size.

Description of the area: The property is zoned CG; (General Commercial District) and the area consists of commercial buildings with zone CG Commercial located in the same area.

Probable effect of the proposed demolition: The demolition of the structure will affect Salt Lake City's housing stock by reducing the number of residential uses by one.

Comments from the public on the impact of proposed demolition: Approve demolition Staff recommendations: City staff recommends demolition.

Lisa Butcher, spouse to the owner, Cory Fox, was present representing the property. She stated that after a tree fell on the house it was leaning to one side and unstable. She commented that she has been working toward the demolition for over a year.

Linda Duff who resides at 916 South Gale Street advised that she is in favor of the demolition, especially since the house is leaning toward her home.

Marlene Jennings motioned to approve the demolition without compensation for the loss. Chris Atkin seconded the motion and the motion passed. Marlene Jennings, Chris Atkin and Jim Schwing voted in favor of the demolition.

Other Business

There was further discussion concerning ordinance 18.97.030 for mitigating residential housing loss, with Katie giving clarification concerning the ordinance.

Marlene Jennings requested further discussion on the mitigation of residential housing laws.
