Trends/Issues Identified and Relayed to the Police Department

No trends were identified during this quarter. CRB continues to review pending K9 cases and will offer suggestions as needed based upon those reviews. CRB recommends that the K9 program consider greatly increased emphasis on training revolving around bite releases. In a recent review of a case, the Handler ordered his K9 to release the bite, at the right time, yet the dog failed to do so until after the 3rd command and roughly 14 seconds. Although there was no evidence that this increased amount of time increased the severity of the A/P's injury, it certainly increased his pain level. In the case cited, the Handler was not at fault, i.e. he ordered the bite released at the soonest opportunity but with the K9 not releasing at the command, the results could be much worse if not corrected as soon as possible.

An OIS remains at the SLCoDA's office that occurred on 4/19/18, over 3 years ago.
