# **City Council Meeting Highlights**

Tuesday, July 9, 2024

### Sports, Entertainment, Culture, and Convention District

Following a briefing, the Council <u>voted to unanimously endorse</u> and submit a participation agreement to the state's Revitalization Zone Committee for their review and approval. The participation agreement, which outlines the project area and how the City and Smith Entertainment Group (SEG) could utilize the proposed sales tax revenue to develop it, included the following public benefits:

- Japantown investments
- Public gathering spaces
- Public safety enhancements
- Public art projects
- Ongoing revenue stream for other public benefits such as family sized affordable housing, to be determined by the Council in the future

After the state Committee review, the agreement will come back to the Council for a final vote on the Participation Agreement and the proposed sales tax authorized by the State Legislature.

#### **Capital Improvement Program**

The Council received a follow-up briefing about the City's Capital Improvement Program (CIP), which involves constructing, purchasing, or renovating buildings, parks, streets, or other city-owned physical structures. The Council also held the first of two scheduled public hearings for CIP. The next briefing and hearing are both scheduled for Aug. 13.

Generally, CIP projects have a useful life of at least five years and cost \$50,000 or more. The Council approves debt service and overall CIP funding in June with the annual budget process, while project-specific funding is approved by Sept. 1 of the same calendar year. The Council discussed allocating funds for several projects that did not receive recommendations for funding from the Mayor, using extra dollars added in the FY25 budget process. Allocations will be finalized at the Aug. 27 Council Meeting.

#### The Council Also:

- Joined Mayor Erin Mendenhall to recognize The Home Depot and its dedicated employees for their service to Salt Lake City.
- As the Salt Lake City Redevelopment Agency (RDA) Board of Directors, received a follow-up briefing and approved the lease rate and terms for USA Climbing's Headquarters and National Training Facility in the City's Rio Grande District. Board Members expressed hope for this catalytic project to provide positive, family-friendly activation for this area.
- Received a briefing and approved an interlocal agreement between the City, RDA, and Utah Inland Port Authority, an action taken as both the RDA Board and Council.
- Received briefings about:
  - proposed amendments to Form-Based Districts,
  - o projecting business signs, which hang off the front of buildings,
  - allowing single-family attached dwellings in select commercial zones where multifamily dwellings are already permitted.
- Discussed and approved a \$100,000 Economic Development Loan for vegan and vegetarian restaurant The Goat Head. The loan will help create four new jobs next year and retain two existing ones.
- Interviewed and approved the appointment of Caitlyn Barhorst and Mark Morris to the <u>City and County Building Conservation and Use Committee</u> Board.
