Tuesday, Nov. 19, 2024

Jordan River Fairpark District

The Council received a follow-up briefing and held a public hearing on creating a new Jordan River Fairpark Zoning District to facilitate the redevelopment of about 93 acres near "The Power District," according to state law. The City and Larry H. Miller Company must reach an agreement by the end of the year for efficient land use reviews and approval for a potential stadium and other related uses.
